This standard describes methods of determining the seat tightness of metal- and soft-seated pressure relief valves, including those of conventional, bellows, and pilot- operated designs. The maximum acceptable leakage rates are defined for pressure relief valves with set pressures from 103 kPa gauge (15 psig) to 41,379 kPa gauge (6000 psig).

API Standard 527

The API standard 598: Valve Inspection and Testing, covers the testing and inspection requirements for gate, globe, check, ball, plug and butterfly valves. It has acceptable leakage rates for liquid as well as gas testing.
