An H1B petition is filed on USCIS Form I-129, along with the Form I-129H supplement and the approved Labor Condition Application (LCA) Form ETA-9035 from the U.S. Department of Labor. Your H1B petition documents must include: 1. Evidence that the proposed employment qualifies as a specialty occupation

USCIS has removed their H1B pre-requisite criteria of submitting these as mandatory documents now: Client letters (now Optional but recommended), SOW (now Optional but recommended), Detail Work Itinerary for each end client work location, and (not required now)

Copy of LCA (Labor Condition Application) Form - According to the H1B 2019 latest news, the employers must provide the latest version of LCA, which is ETA Form 9035, to disclose information about the type, location, salary etc. to be paid to the foreign worker.
