The Salon Independent Contractor Agreement establishes a binding arrangement between a hair stylist or barber and a salon company. In most cases, the hair stylist acts as an independent contractor that is responsible for obtaining their own clients and customers. Therefore, the salon company will generally provide the booth, most of the equipment, and training in exchange for a percentage (%) of the hair stylist's sales.

The hairstylist independent contractor agreement is used to officially outline the terms of a working arrangement between a company (usually a salon or barbershop) and professional hairstylists. Often barbers and hairstylists will pay the business owner to rent their workspace (“chair”) on a daily, weekly, or monthly basis. It is also common for the stylist to receive a percentage of profits that are paid out as a commission.

Independent contractors are contracted, responsible for all of their own taxes, and do not answer to a salon owner except to ensure the contract terms have been fulfilled. Independent contractors must be provided with a 1099 form at the end of the year by any person who has contracted them and paid them more than \$600 in that year.

Know Your Rights in the Salon: Employee, Independent ...

A hair salon booth rental agreement must include a contract between you and the owner of the salon. This legally binding contract protects you, the salon owner, as well as the stylist. It is the document the IRS uses as proof that your leasees are independent and not employees. A salon booth rental agreement includes the rent/lease rate and how cancellation can take place.

Description. This form is an independent employment agreement. The employee agrees not to compete with the employer for a period of time specified within the contract. The employer will pay all compensation in gross and without tax deductions. The form provides that the employee will be responsible for paying all taxes.

Self-Employed Independent Contractor Employment Agreement ...

An “independent contractor” is the massage therapist who agrees to do chair massages in your hair salon for a bridal party. This therapist comes in, does the work in accordance with the event’s work agreement, takes her payment, and leaves. She does not sit in the salon and wait for clients.

Salon owners who choose to use the services of independent contractors or lessee-workers should obtain legal advice when putting together an independent contractor agreement, or a lease for booth rental, etc. Involving an attorney and/or other employment tax professional in the overall self-audit process is highly recommended.

The salon and barber believe that they are in an employment relationship. The salon and stylist believe that the hair stylist is an independent contractor.
