The 'new' Red Book was intended to replace the 1992 Fourth Edition of the Red Book, with the ambition that its use would cease with time.

The Yellow Book Subcontract is the first standard form intended for use with the 1999 FIDIC Conditions of Contract for Plant and Design-Build (the "1999 Yellow Book"). The Clauses of general application in the Yellow Book Subcontract are similar to those in the 2011 FIDIC First Edition Conditions of Subcontract for Construction, known as the "Red Book Subcontract".
